SAFETEA-LU

Safe Routes to School was enacted by the 2006 SAFETEA-LU Federal Transportation Bill placed under the direction of the Federal Highway Administration. The purpose of its creation is "to enable and encourage children, including those with disabilities, to walk and bicycle to school; to make bicycling and walking to school a safer and more appealing transportation alternative, thereby encouraging a healthy and active lifestyle from an early age; and to facilitate the planning, development, and implementation of projects and activities that will improve safety and reduce traffic, fuel consumption, and air pollution in the vicinity of schools".

TDOT & MPO/TPO

Funds for the program are managed by the State of Tennessee Department of Transportation (TDOT) under the direction of the Long-Range Planning Division Safe Routes to School Coordinator John Houghton (interim) and expected to be funneled through the local Metropolitan Transportation Organization known as the Chattanooga-Hamilton County / North Georgia Transportation Planning Organization (TPO). Local allocation of these funds is expected towards the end of 2006.

Hamilton SRTS & Activate Chattanooga

Who's who?

Hamilton County SRTS program planning & coordination is guided by **Activate Chattaneoga** a coalition of planning, health, city and county engineering, university, school system, and community professionals proactively addressing community design to improve health and reduce inactivity. A list of members is attached.

What have we done?

Over the last few months Activate Chattanooga members have been working to understand the SRTS program and how it may best be implemented in Hamilton County. Members participated in a school selection workshop to select the 10 most suitable schools to begin SRTS programming. The selection criteria included elementary or middle school, student arrival and departure safety issues, neighborhood proximity, pedestrian and bicycle infrastructure, and traffic congestion issues. 
Sam Edwards wrapped up Thursday's session with an update on legislative affairs. This being an election year, little is expected to occur.

On Friday Bridget Jones, Executive Director of Cumberland Region Tomorrow, opened with an update on the Quality Growth Toolbox that the organization is helping to develop. Jim Ozment, Tennessee Department of Transportation, and Darlene Reiter, Bowlby & Associates, presented TDOT's new traffic noise policy and discussed the concept of noise compatible land use planning. Ed Cole, TDOT's Chief of Environment and Planning, gave a brief update on the status of TDOT's Long Range Transportation Plan. He then discussed the need for TDOT, TAPA, and other professional groups and organizations to work together to further the goal of making citizens and local officials aware of the link between land use and transportation. Valerie Birch, Parsons Brinckerhoff, provided an update on the Context Sensitive Solutions approach to transportation projects in Tennessee.

One of the most eagerly anticipated events of the annual Winter Retreat is Cabin Fever, and this year was no exception. Monica Austin made the event even more exciting by involving everyone in a rousing game of Planning Pictionary. It was a blast!










- Bridget Jones, Cumberland Region Tomorrow presents the Quality Growth Toolbox.

Gulf Hurricanes Increase Construction Costs in Tennessee

The extraordinary damage caused by the hurricanes that battered the Gulf Coast in August 2005 has had wide-reaching effects. Material and labor costs have surged in the Southeast as Gulf region rebuilding continues. The Board of Tennessee Housing Development Agency (THDA) offered some relief to affordable housing developers working in Tennessee.

Of the five Low Income Housing Tax Credit developments underway in Washington County, three have made application for relief.

The Housing and Development Reporter noted prices had been rising before Hurricane Katrina as a result of increased construction across the country, flat production of materials by existing plants, and an increased need for building supplies for recovery efforts in Florida following the 2004 hurricanes. Katrina further limited supplies by damaging gypsum wallboard and other construction material production plants in Louisiana and the Gulf region.

The THDA Board responded at its March meeting by offering developers some financial relief. Housing developers who had received awards of Low Income Housing Tax Credits in 2004 or 2005 were offered the opportunity to apply for "extraordinary relief" if certain criteria were in effect. Developers could apply for additional credits, or reduce the number of units being presented. Developments where financing had closed before August 28 were not eligible for additional credit. The Board felt those projects had been insulated from the labor and materials increases related to the hurricanes.

The federal Low Income Housing Tax Credit (LIHTC) was designed to encourage the construction and rehabilitation of rental housing for individuals and families of very low and low income. THDA administers the LIHTC in Tennessee. The state receives an allocation reflecting \$1.90, plus the cost of living adjustment specified in the tax

credit law (Section 42), per Tennessee resident. Each year, THDA includes any unallocated credits from the previous year, credits returned during the previous year, and any allocation from a national pool of unused credit. In turn, developers apply for a reservation of those credits to support housing development costs. The credit is used to offset the federal income tax liability of the development's owners. The program has allocated credits for the development of over 30,000 units in Tennessee since the program's creation by Congress in 1986.

"The LIHTC is the only tool offered by the federal government to encourage affordable rental housing development," said THDA Board Chair Eddie Latimer. "Developers know from THDA and others" research that the lack of affordable rental housing is interfering with Tennessee's growth, and the stability of its families. Looking from a business perspective, there are financial risks involved and a low profit margin for this type of housing. The Tax Credit makes it feasible. The extraordinary costs from the hurricanes increased the risks. I'm glad the Board showed leadership by offering the developers options."

The application deadline for the 2006 Extraordinary Relief Tax Credit was March 31, 2006. A list of competitive 2006 tax credit applicants to which THDA anticipates issuing Reservation Notices will be posted to the Agency's website in early July.

were rated on having or not having these criteria then ranked accordingly upon discussion of each criterion. The list of 10 priority schools is attached. These schools are listed by suitability, the first being the most suitable. Additional schools will be added as school interest or request occurs. For example, Battle Academy heard of the program and requested to be included in the initial process.

Where are we now?

Activate Chattanooga is in the process of outlining program components and assigning responsibilities. Though funding may not be available for this year's initial kick-off, the group expects to identify eligible priority projects to be considered for funding next year. To qualify for project funding, the program must be comprehensive and address the following elements known as FHWA SRTS program's the "5 E's": Education, Evaluation, Engineering, Enforcement, and Encouragement. At present, Activate Chattanooga has discussed all but one of these elements and that is enforcement. In order to gauge the challenges of the enforcement component, the group presented the program at the Advisory Council on Traffic Safety on April 26th, 2006 and was well received. Meetings with the school patrol & other law enforcement officers are expected in May. Aside from the process mentioned in this packet produced by Activate Chattanooga, no other local guidance exists for the development of SRTS projects and their implementation. As a member of Activate Chattanooga, the local MPO/ TPO (Transportation Planning Organization) is aware of the group's progress and will be a primary agency in the funding process.

Project Funding Eligible Projects

As previously mentioned, the project must be part of a comprehensive program. A project, once demonstrated

State of Franklin Section Hosts Local MPO/RTPO Coordination Seminar:

Attendees Learned Where to Turn to When the MPO Planning Boundary Dead-ends in Their Communities

The State of Franklin Section of TAPA hosted its third hour-long continuing education seminar on Friday, May 12th to assist local Planning Commissioners, Boards of Zoning Appeals members and area-wide planners in obtaining their state-mandated annual training hours. As Section Director, Ambre Torbett, AICP, coordinated the event and introduced the three speakers: Bill Albright, coordinator of the Kingsport MPO; Rex Montgomery, coordinator of the Bristol MPO; and Matt Garland the new Rural Transportation Planning Organization coordinator.

The purpose of the meeting was to not only assist in obtaining certifiable continuing education, but to help community leaders learn about the new avenue for rural transportation planning and how the MPOs, RTPOs and TDOT coordinate transportation needs and prospective projects. It is hoped that with the creation of the RTPOs across the State, rural local governments will have more input into the transportation planning process - from public transit, enhancements, safety issues, bike routes, to highway funding. Attendees learned about the current planning efforts of each agency, the new TDOT Long-Range Plan and how each community can get involved in these planning efforts.

Bill Albright spoke about the current projects of his region and the Long-Range Plan. He also briefed folks on the Context Sensitive Solutions process in which he and a local resource team recently

participated for the Highway 126/Memorial Boulevard project overseen by TDOT. Rex Montgomery presented a fact sheet on the purpose of a Metropolitan Planning Organization, the Transportation Planning Process and the long-range planning efforts of Bristol MPO. Matt Garland presented maps of the First Tennessee Development District region wherein he assists local governments with rural transportation planning needs. Rich DesGrosseiliers, coordinator of the Morristown MTPO was also present to answer any questions from the planners, as his study boundary is contiguous with the upper east Tennessee region. Over forty planners and board members attended the seminar over a "Dutch-treat" luncheon, which was held at the newly renovated Sunny's Restaurant located in an historic warehouse in downtown Johnson City. TAPA President, Steve Neilson, AICP, certified the program as attendees received a TAPA Certificate. to be part of a comprehensive program, is eligible for funding as either a "hard" or "soft" project. Approximately 70 percent of the available funding can be used for physical construction projects and a remaining 30 percent for educational, outreach, and/or marketing projects. Together, these hard and soft projects are expected to produce the following outcomes as stated by the FHWA:

- Increase bicycle, pedestrian, and traffic safety
- More children walking and bicycling to and from school
- · Decrease traffic congestion
- · Improve childhood health
- · Reduce childhood obesity
- Encouragement of healthy and active lifestyles
- · Improved air quality
- · Improved community safety
- · Reduced fuel consumption
- · Increased community security
- Increased community involvement
- Improvements to the physical environment that increase the ability to walk and bicycle to and from schools
- Improved partnerships among schools, local municipalities, parents, and other community groups, including non-profit organizations
- Increased interest in bicycle and pedestrian accommodations throughout the community

The agency under which the project is being developed or engineered, otherwise known as the applicant, can be a local government or under certain conditions a non-profit agency.

Possible Selection Process

As with any state managed program, there will be an application and selection process. At this time it is not apparent as to how the State of Tennessee Department of Transportation plans to allocate these funds, but a statewide meeting is being planned to address this and other SRTS issues. Activate Chattanooga hopes to serve as the recommending review committee for project selection prior to any state or local board decision.


Results of the 2006 APA-AICP election were announced April 25, 2006, at the APA National Planning Conference in San Antonio. The winners will take office on June 6, 2006.
